## **Privacy Policy**

# **Privacy Policy:**

Protecting your private information is our priority. This Statement of Privacy applies to squatgang.com, and EDLO, LLC and governs data collection and usage. The Squat Gang website is a Marketing & Promotions site. By using the Squat Gang website, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

In order to better provide you with products and services offered, Squat Gang may collect personally identifiable information, such as your:

- First and Last Name
- Mailing & Physical Address
- E-mail Address
- Phone Number
- Information about your home such as gate locations, areas to be cleaned.
- Information about your pets including names & birthdays.

If you purchase Squat Gang products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Squat Gang may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender
- Household Income
- Locations

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through Squat Gang's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

### **Use of your Personal Information**

Squat Gang collects and uses your personal information to operate and deliver the services you have requested.

Squat Gang may also use your personally identifiable information to inform you of other products or services available from Squat Gang and its affiliates.

### **Sharing Information with Third Parties**

Squat Gang does not sell, rent or lease its customer lists to third parties.

Squat Gang may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party. Squat Gang may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Squat Gang, and they are required to maintain the confidentiality of your information.

Squat Gang may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Squat Gang or the site; (b) protect and defend the rights or property of Squat Gang; and/or (c) act under exigent circumstances to protect the personal safety of users of Squat Gang, or the public.

Squat Gang may utilize user information on 3rd party advertising platforms such as google ads, facebook ads, or other social media sites, and marketing channels.

Squat Gang may also conduct user surveys with 3rd party software with information collected.

### **Opt-Out of Disclosure of Personal Information to Third Parties**

In connection with any personal information we may disclose to a third party for a business purpose, you have the right to know:

The categories of personal information that we disclosed about you for a business purpose.

You have the right under the California Consumer Privacy Act of 2018 (CCPA) and certain other privacy and data protection laws, as applicable, to opt-out of the disclosure of your personal information. # **Tracking User Behavior**

Squat Gang may keep track of the websites and pages our users visit within Squat Gang, in order to determine what Squat Gang services are the most popular. # **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by Squat Gang. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Squat Gang website.

#### **Use of Cookies**

The Squat Gang website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. - Detect security incidents, protect against malicious, deceptive, fraudulent,
   or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his
  or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;

- Engage in public or peer-reviewed scientific, historical, or statistical
  research in the public interest that adheres to all other applicable ethics
  and privacy laws, when our deletion of the information is likely to render
  impossible or seriously impair the achievement of such research, provided
  we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

#### **Children Under Thirteen**
